BATTELLE SAVANNAH RIVER ALLIANCE, LLC RETIREE WELFARE BENEFIT PLAN**

This is a summary of the annual report of the Battelle Savannah River Alliance, LLC Retiree Welfare Benefit Plan (Employer Identification Number 85-0942867, Plan Number 502) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Battelle Savannah River Alliance, LLC has committed itself to pay certain claims incurred under the terms of the plan.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$10 as of the end of plan year, compared to \$14,892 as of the beginning of the plan year. During the plan year the plan experienced a decrease in its net assets of \$14,882. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$132,733 including employee contributions of \$132,733. Plan expenses were \$147,615. These expenses included \$147,615 in benefits paid to participants and beneficiaries.
