**FOLLOWING IS A SUMMARY ANNUAL REPORT NOTICE THAT THE HEALTH CARE BENEFIT PLANS ARE REQUIRED TO PROVIDE TO PLAN PARTICIPANTS**

This is a summary of the annual report of the Savannah River Nuclear Solutions Pre-65 Retiree Health Plan (Employer Identification Number 26-0240191, Plan Number 509) for the plan year 01/01/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Savannah River Nuclear Solutions, LLC has committed itself to pay certain health and dental claims incurred under the terms of the plan.

**Basic Financial Statement:** The value of plan assets, after subtracting liabilities of the plan, was \$43,118 as of the end of plan year, compared to \$162,418 as of the beginning of the plan year. During the plan year the plan experienced a decrease in its net assets of \$119,300. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$33,788,960 including employer contributions of \$25,890,743 and employee contributions of \$7,898,217. Plan expenses were \$33,908,260. These expenses included \$1,325,940 in administrative expenses, and \$32,582,320 in benefits paid to participants and beneficiaries.

**Paperwork Reduction Act Statement:** According to the Paperwork Reduction Act of 1995 (Pub.
