FOLLOWING IS A SUMMARY ANNUAL REPORT NOTICE THAT THE HEALTH CARE BENEFIT PLANS ARE REQUIRED TO PROVIDE TO PLAN PARTICIPANTS

This is a summary of the annual report of the Savannah River Remediation Pre-65 Retiree Health Plan (Employer Identification Number 35-6987237, Plan Number 509) for the plan year 01/01/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Savannah River Remediation LLC has committed itself to pay certain health and dental claims incurred under the terms of the plan.

Basic Financial Statement: The value of plan assets, after subtracting liabilities of the plan, was \$80,239 as of the end of plan year, compared to \$48,296 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$31,943. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$6,319,422 including employer contributions of \$4,864,004, and employee contributions of \$1,455,418. Plan expenses were \$6,287,479. These expenses included \$242,744 in administrative expenses and \$6,044,735 in benefits paid to participants and beneficiaries.

You also have the legally protected right to examine the annual report at the main office of the plan: Savannah River Remediation, LLC, SRR Benefits Committee, Building 766-H, Room 1066F, Aiken, SC 29808, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
