Risk Management and Future Use Subcommittee

Meeting Record
March 23, 1998
Folly Island, SC

The Risk Management and Future Use (RM&FU) Subcommittee of the Savannah River Site (SRS) Citizens Advisory Board (CAB) met on March 23, 1998, at 7:30 p.m. at the Charleston On The Beach hotel, Folly Beach, S. C. The topics discussed were the RM&FU Subcommittee CAB recommendation, the six (6) month schedule and the Risk Management Working Group. Members of the CAB in attendance were P. K. Smith, Bill Adams, and Brendolyn Jenkins. Walt Joseph, the CAB Facilitator, was present. Jim Brownlow and Kim Newell represented South Carolina Department of Health and Environmental Control. John Stockwell and Laurie Hunt represented the Environmental Protection Agency. Lynn Waishwell represented the Consortium for Risk Evaluation and Stakeholder Participation. Kristi Branch represented the Pacific Northwest National Laboratory. Gary Little from the Department of Energy Savannah River Operations Office (DOE-SR) attended as the Associated Deputy Health and Environmental Control. The Westinghouse Savannah River Company (WSRC) attendee was Jim Moore.

P. K. Smith, Chairperson, welcomed all the attendees and had them introduce themselves. Ms. Smith then handed out copies of the draft motion on the Accelerating Cleanup: Paths to Closure that was to be presented to the CAB on March 24, 1998. The recommendation requested an extension on the comment period for the ACP from May 1 to May 22, 1998. This extension allows time for the CAB to review, modify and approve the RM&FU Subcommittee recommendation on May 19, 1998. Ms. Smith requested all in attendance to read the recommendation and comment on it. After the recommendation was read, there was one correction which was incorporated. Ms. Smith requested that all members get their comments on the ACP in to either Gary Little, DOE-SR, Jim Moore, WSRC, or herself as soon as possible.

Ms. Smith handed out copies of the six (6) month schedule for review. She explained how to read the matrix and asked for input or comments. Ms. Smith stressed that this working schedule was tentative and one should not assume a meeting would be held as listed. She stated that notices would go out for those meetings actually scheduled. There were no comments related to the schedule.

P. K. Smith explained that she was interested in setting up a Risk Management Working Group and was working on determining some general objectives and goals for the Working Group. She requested any input from those members present. There was some discussion on what the committee would do. Mr. John Stockwell of the Environmental Protection Agency (EPA) requested that the EPA intern, Laurie Hunt, be included on the Working Group.

P. K. Smith adjourned the meeting.
