**Welcome and Introduction:**

CAB member Clint Nangle opened the meeting by allowing everyone attending to introduce themselves. He asked everyone to introduce themselves, including online attendees. He reviewed the meeting's agenda and reminded everyone to state their name before making comments. When providing the recommendation status update, he mentioned recommendations 288 and 289 were open and 292 and 302 are pending. However, per Mr. Nangle's suggestion, recommendations 289 and 292 were closed. He addressed recommendation 302, which is the joint recommendation with the Nuclear Materials Committee, and was passed at the October Full Board meeting.

CAB member Nangle introduced Ms. Karen Adams, DOE-SR, who presented on the "Asset Revitalization Initiative Update."

**Presentation: Asset Revitalization Initiative Update-Karen Adams, DOE-SR**

Ms. Adams stated the purpose of her presentation was to provide a report on the efforts of the DOE-HQ Asset Revitalization Initiative (ARI) Task Force and describe the accomplishments and path forward for the SRS Asset Revitalization Team. She provided brief background information about the ARI program along with certain goals the task force hopes to accomplish. She provided a diagram which showed the different types of revitalization and reuse efforts

underway across the United States. She explained how the DOE-HQ ARI Task Force was developed and said the teams are cross-functional. She stated the goal of the SRS Asset Revitalization Project Team is to maximize asset use, availability, and potential reuse for new and long-term missions.
