## **Interim Action Determined by DOE for Surveillance Program Plutonium**

The Department of Energy - Savannah River (DOE-SR) has determined that processing up to 180 kilograms of plutonium, from the plutonium surveillance program required by DOE Standard 3013, is an allowable interim action in accordance with DOE's National Environmental Policy Act (NEPA) regulations. This action can take place in advance of any record of decision on the ongoing Surplus Plutonium Disposition (SPD) Supplemental Environmental Impact Statement (SEIS) because it has no adverse environmental impacts and it will not affect the selection of an alternative for the disposition of a much larger quantity of plutonium that is the subject of the SPD SEIS.

## **Supplement Analysis to the Surplus Plutonium Disposition EIS**

The National Nuclear Security Administration has completed a Supplement Analysis and issued an Amended Record of Decision for the Waste Solidification Building at the SRS. DOE has decided to construct and operate the Waste Solidification Building for treating and solidifying liquid transuranic waste and certain liquid low-level radioactive wastes from the Mixed Fuel Fabrication Facility and the Pit Disassembly and Conversion Facility.
