SC DEPARTMENT OF HEALTH AND ENVIRONMENTAL CONTROL PUBLIC NOTICE Notice of Draft Determinations

SRS 288-F Class 2 Landfill Expansion, Aiken County

The South Carolina Department of Health and Environmental Control's (SC DHEC) Solid Waste Permitting Section has received a determination request from SRS for a Class Two landfill expansion at SRS 288-F in Aiken County. These determinations are a preliminary step in the landfill permitting process.

Pursuant to Regulation 61-107.19 and prior to submittal of a permit application to the Department for an expanded new Class Two Landfill, the application has requested and received the following draft determinations by the Department:

1. That the proposed landfill is consistent with local zoning, land use and any other applicable ordinances, and
2. The landfill area is not located within 1000 feet of any residence, day-care center, church, school, hospital, or publicly owned recreational park.

The public is hereby notified that the Department has prepared draft determinations relevant to the site indicated above and that these determinations may be reviewed by appointment during normal working hours at the following locations:

Any interested person(s) may submit written comments concerning the draft determinations for zoning, land use, and buffers to this mailing address: Mr. John Schnabel, BLWM, SC DHEC, 2600 Bull Street, Columbia, SC 29201. To be considered, all comments or requests should be received no later than 5:00 p.m. on May 1, 2009, at which time the public comment period will end.

Interested parties may also include a request for a public hearing. The Department will conduct a public hearing upon receipt of requests in writing by 10 persons or by governmental subdivision or agency or by an association having not less than 10 members.
