## **PUBLIC INVITED TO PARTICIPATE IN NRC/DOE CONFERENCE CALLS DISCUSSING THE F-TANK FARM DRAFT WASTE DETERMINATION BASIS FOR SRS**

The U.S. Department of Energy (DOE) and U.S. Nuclear Regulatory Commission (NRC) will hold weekly public conference calls to discuss NRC's Request for Additional Information on DOE's F-Tank Farm Draft Waste Determination Basis for the Savannah River Site (SRS), published on September 30, 2010.
