## Class 2 notice

### **Hazardous Waste Permit Modification Requested to Savannah River Site's (SRS) 1992 Resource Conservation and Recovery Act (RCRA) Part B Permit Renewal Applications for Volume IV and V**

The United States Department of Energy (DOE)-Savannah River Operations Office has requested from the South Carolina Department of Health and Environmental Control (SCDHEC) modifications to Savannah River Site's (SRS) 1992 Resource Conservation and Recovery Act (RCRA) Part B Permit Renewal Applications for Volume IV and V.

These revisions (Revision 27 of Volume IV and Revision 26 of Volume V) propose to extend the Phase 2a goal dates to meet the non-tritium groundwater protection standard constituents in Fourmile Branch by October 31, 2017, and the Phase 2b goal dates to meet the non-tritium groundwater protection standard constituents in the Fourmile Branch seep lines by July 31, 2020.

This notice begins a 60 day comment period. More information, including the actual permit applications, is available for review and copying at the DOE Public Reading Room located in the University of South Carolina-Aiken Library, or by contacting personnel identified in this notice. The Permittee's compliance history during the life of the permit being modified is available from SCDHEC.

A public meeting will be held on Thursday, March 1, 3:00 p.m. at the Aiken County Public Library. Representatives from SRS will be available to answer questions on the modifications. Written Comments may be sent to SCDHEC. All comments will be considered in the final decision.
