## *Public Comment Period Extension and Public Meeting Notice for the Early Action Statement of Basis / Proposed Plan for the C-Area Operable Unit*

The United States Department of Energy (DOE) announces a 30-day extension to the 45-day public comment period on the Early Action Statement of Basis / Proposed Plan (SB/PP) for the C-Area Operable Unit (CAOU). As concluded in the Early Action SB/PP, a remedial action is needed at the CAOU due to the contamination present within several of the CAOU subunits that may pose a threat to human health. Groundwater is not considered part of the CAOU and will be addressed in the C-Area Groundwater Operable Unit. The preferred alternative for the CAOU subunits is a combination of No Action and Land Use Controls.

The forty-five (45) day public comment period was originally scheduled for November 17, 2014 to January 1, 2015. The additional 30-days extend the public comment period to January 31, 2015 and will provide the interested parties additional time to comment on the preferred remedy for the CAOU. In addition, a public meeting will be held to discuss the preferred remedy. The DOE will consider all comments submitted within the revised public comment period.
