## SAVANNAH RIVER SITE ACCEPTABLE ID LIST

All visitors to the Savannah River Site must provide **two forms** of identification to receive a Visitor's Badge granting access to the site.

- One must be a valid photo identification document from **List A** below.
- The second can be from either List A or List B.
