Insurance Information: The plan has an insurance contract with The Prudential Insurance Company of America to pay certain life insurance claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2017 were \$6,824,434.

Basic Financial Statement: The value of plan assets, after subtracting liabilities of the plan, was \$0 as of the end of plan year, compared to \$0 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$0. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$6,849,252 including employer contributions of \$267,043, employee contributions of \$6,582,203, gains/(losses) of \$0 from the sale of assets, and earnings from investments of \$6. Plan expenses were \$6,849,252. These expenses included \$28,000 in administrative expenses, \$6,821,252 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
