Insurance Information: The plan has an insurance contract with Prudential Insurance Company of America to pay certain life insurance and accidental death and disability claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2018 were \$4,872,246.

This is a summary of the annual report of the Savannah River Nuclear Solutions, LLC Contributory Group Term Life Ins. Plan (Employer Identification Number 38-3787673, Plan Number 508) for the plan year 01/01/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information: The plan has an insurance contract with the Prudential Insurance Company of America to pay certain life insurance and temporary disability claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2018 were \$7,051,672. **Basic Financial Statement:** The value of plan assets, after subtracting liabilities of the plan, was \$0 as of the end of plan year, compared to \$0 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$0. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$7,075,613 including employer contributions of \$266,450, employee contributions of \$6,809,148, and earnings from investments of \$15. Plan expenses were \$7,075,613. These expenses included \$31,000 in administrative expenses and \$7,044,613 in benefits paid to participants and beneficiaries.
