### What is EEOICPA

The Energy Employees Occupational Illness Compensation Program Act (EEOICPA) was passed by Congress in 2000, and amended in October, 2004. It provides compensation to workers or their survivors for illnesses caused by exposure to radiation or other toxic hazards during employment in the nuclear weapons industry. Applicants who qualify may receive both cash benefits and payment for medical costs attributed to the illness for which compensation was awarded.

#### Who is eligible for EEOICPA benefits?

Part B of EEOICPA provides lump sum benefits up to \$150,000 to qualified claimants (or survivors) who are found to have worked at a covered facility and developed cancer, beryllium disease, or silicosis.

Part E of EEOICPA provides benefits to eligible contractor and subcontractor employees (or qualifying survivors of these workers) who worked in covered DOE facilities.

Resource centers are available to help employees or their families file for benefits under EEOICPA. To find the resource center nearest you, call toll free at 866-888-3322.

By taking part in the *Building Trades National Medical Screening Program*, you can find out if you have a compensable illness.

## What is this Program?

This program provides a free medical screening for construction workers who worked on certain Department of Energy sites. This program is supported by the Building and Construction Trades Department, AFL-CIO.

### **You may be eligible to participate in this program if:**

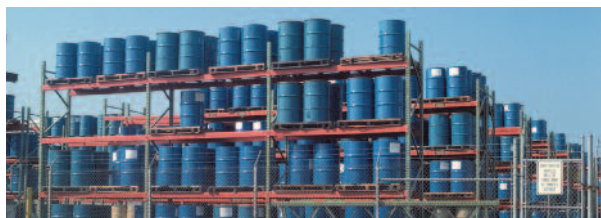
You performed construction work (for either the prime or subcontractors) at any time in the past at any of the following DOE sites. Even if you don't now live near the DOE site, you can still participate.

**And...** You think you may have been exposed to any health hazard including radiation, beryllium, asbestos, silica, mercury, cadmium, nickel, lead or other heavy metals, solvents or degreasers, or any other fumes, vapors or dusts, or noise.

**Or...** You or your doctor think you have health problems as a result of your DOE work.



## How Does the Program Work?

You call our toll-free number, mail the tear-off postcard, or visit our web site at [www.btmed.org](http://www.btmed.org).

Our staff will set up a confidential work history interview with you. The interview will help highlight any health hazards and exposures from your work at the DOE site. The interview can be conducted in person, on the telephone, or on-line.



The information from your interview is reviewed by specialists in occupational health. After the interview, the Program will arrange for a free medical screening

with the appropriate tests. The medical screening is a physical exam and other special tests to detect possible health problems related to your exposures.

## When and Where Can I Schedule a Medical Examination?

We have more than 200 credentialed medical providers located across the United States. Chances are there is one close to where you live. We will work with you to find a provider close by.

Shortly after your exam, the Program will send you your results and tell you if you need more testing or treatment. Although the Program cannot pay for additional medical treatment, we can assist you in referrals for further medical care.

All results are kept confidential. Your results will only be sent to you unless you tell us otherwise.



## What Can the Program Do for Me?

- Information you provide during the work history interview may indicate whether you were exposed without your knowledge. That enables us to do a special medical exam to see if you have any health problems that may be related to your work at a DOE site.
- If you have a work-related problem, we will refer you to the EEOICPA program established by Congress.
- The medical exam also detects other medical problems that you may not be aware of, like high blood pressure or diabetes, which can be treated by your doctor.



- The medical exam can help find health problems before they become serious. We can help to arrange follow-up medical care when needed. These screening programs have already saved many lives.
- The information you provide can be used to better protect the health of current and future workers. We have used such information already to determine that construction workers at many DOE sites need to be protected better during maintenance, renovation, repair, and demolition work. Without the information provided in the interviews, this would not have happened.
