To increase your chances for funding, please keep in mind these characteristics when developing your mini grant application:

Good mini grant projects

- Show usefulness over long periods of time
- Can be easily set up and handle frequent use
- Benefit large numbers of students
- Capture students' interest
- Provide unique and/or higher concept learning
- Address curriculum standards
- Are appropriate for the grade level

In addition, information on the application should

- Be neatly organized
- Contain reference information (e.g. vendor information, etc.)
- Itemized total budget must not have a shortfall of more than 10% of the total amount requested (\$50 for CAT A, \$75 for CAT B, \$100 for CAT C)

- Educators may now submit grant applications online! As we transition to electronic submission, grants may still arrive by mail.
- Rule Change: Educators may only be associated with one (1) grant in any role, either as lead teacher or team member.

Proposals will be evaluated by a panel of judges based on the criteria listed in this brochure.

Eligibility


- Public and private elementary and middle school educators who teach/work in one of the following CSRA counties: Aiken, Allendale, Bamberg, Barnwell or Edgefield (SC); and Columbia or Richmond counties (GA) may apply.
- Guidance counselors may apply for mini grants as long as it's demonstrated that the project will benefit elementary and middle school students in the classroom.
- Applicants do not have to be science, math or technology teachers to be eligible for a mini grant. The grant writer must demonstrate that the project will enhance those concepts in the classroom.
- Previously submitted grants will not be sent to applicants to be used as examples. This would give an unfair advantage to those not receiving copies of previously submitted grants.
- From a SRNS perspective, materials, supplies and equipment become property of the winning teacher. However, teachers should check with their schools. Some schools do take ownership of the materials.

Selection committee criteria

- Goals and objectives clearly stated and measurable
- Project directly involves students
- Evaluation component
- Budget is reasonable, appropriate, and specific. Itemized total dollar amount must not have a shortfall of more than 10% of the total amount requested (\$50 for CAT A, \$75 for CAT B, \$100 for CAT C)

Additional criteria for Categories B and C:

- Proposal contains a Project Plan with evaluation component.
- Implementation Schedule is reasonable.
- Integrates technology with instruction.
- Promotes scientific methodology, problem solving and higher order thinking skills.
- Potential for replication.



Checklist/Rules

- Mail-In proposals must be submitted on the current year's application form.
- Your name may only be associated with one (1) grant in any role, either as lead teacher or team member.
- Grant Applications must not contain any identifiable information of school or teacher.
- A team shall consist of no more than three members including the lead educator.
- Proposals that received funding may not be re-submitted unless the project is of an refurbishment nature.
- The budget cost of the project should reflect the applied category dollar amount, no more than a 10% shortfall.
- Proposals will be evaluated by a panel of judges based on the criteria listed in this brochure.
- Principals and participants will be notified of the final results according to schedule.
