 Mr. Hennessey presented a briefing on the 2016 Appendix E submittal, which provides a lifecycle list of cleanup milestones for SRS waste. The appendix includes regulatory enforcement milestones for the current fiscal year and up to three additional years. He reviewed the documents and processes identified in the Appendix. Mr. Hennessey presented the changes made to the Appendix for FY 2016, which changed to the 5-year remedy review dates.
