 Strategic & Legacy Management (S&LR) Committee Meeting

Committee Welcome: Bob Doerr, Committee Chair
 Mr. Doerr welcomed everyone to the meeting.

Point of Contact Status Update: Zach Todd, DOE-SR
 Mr. Todd reviewed the Point of Contact projects. Congress has passed an extension to the continuing resolution that funds SRS through April of 2017. The strategic plan is still pending approval at SRS once it is approved, it will be routed to EM Headquarters for approval prior to release for public comments.
 Mr. Todd responded to questions from the CAB members.

Presentation: SRS Archaeology Program: George Wingard, SRAP
 Mr. Wingard gave a comprehensive overview of the Archaeology Program. He reviewed the purpose of the program and gave an historical breakdown of life on site before the Department of Energy plant was constructed. He explained the resident's day to day activities including religion, law enforcement, medical offices, schools and agriculture. Mr. Wingard concluded his presentation by discussing a key archaeological find, Dave's jar. The jar is the only Dave's jar that has been archaeological excavated.
 CAB Members asked for additional details on certain subject areas to which Ms. Berry responded.

Presentation: EM Metrics Update: Zach Todd, DOE-SR
 Mr. Todd reviewed the performance results from the 2016 Fiscal Year. He covered background information on the EM Cleanup Program at SRS. Mr. Todd also stated that DOE-SR will continue to track & monitor performance measures for the key operational areas of EM cleanup operations and suggestions from the CAB for additional improvements are welcomed.
 Mr. Todd and Jim Giusti responded to several questions from the CAB members and the public.

Committee Discussion

Bob Doerr, SLM Chair acknowledged the receipt of DOE's response to Recommendation #338- Revision of the SRS Community Involvement Plan.

David Hoel, CAB Member, offered comments regarding EPA's guidance concerning CIPs.

Mr. Doerr offers to allocate time during committee meetings to address community concerns and asks the committee if they concur with DOE's response.

Nina Spinelli, CAB Vice-Chair suggested the committee close the recommendation and write a new recommendation regarding funding of case mining.

David Hoel stated that the initial recommendation doesn't require additional funding.

Harold Simon, CAB Chair stated that you can draft a response to DOE stating their concerns and asking DOE to clarify their response.

Bob Doerr moves to keep the recommendation open and notes that a follow up letter will be drafted regarding DOE's response.

Michael Mikolanis, DOE-SR suggests the committee include any additional information to support the CAB's position.

David Hoel commented on the President-elect's transition team and DOE.

The Committee also offered comments on upcoming and past events.
