

Summary Notes – April 18, 2018  
 Savannah River Site (SRS) Citizens Advisory Board (CAB)  
 Strategic & Legacy Management (SLM) Committee Meeting

The SLM Committee held a meeting on Wednesday, April 18<sup>th</sup>, 2018, from 6:30 – 8:20 pm, at the Department of Energy Meeting Center in Aiken, SC. It was also streamed online via YouTube and posted to the CAB website and YouTube channel. The purpose of this meeting was to receive updates on the Point of Contact status. There was also time set aside for committee discussion and public comments.

Committee Welcome: Dan Kaminski, SLM Chair

Mr. Kaminski welcomed everyone to the meeting.

Point of Contact Status Update: Zachary Todd, DOE-SR

Mr. Todd gave a status update on any projects at SRS pertaining to the committee scope.

Q&A Session

Mr. Vovakes asked why most strategic plans are online but not DOE. Mr. Todd answered that DOE's plan was last approved in 2015 and it is expected to come down the pipe soon.

Mr. Howard asked how much land will the military be getting on SRS. Mr. Todd asked him to clarify between use or permit. Mr. Howard replied use. Mr. Todd then responded about 108,000 acres use and about 750,000 permit.

Mr. Kaminski asked for a timeline for the DOE strategic plan, to which Mr. Todd answered that according to EM HQ, EM1 is being given the opportunity for input. Mr. Kaminski asked if the 2019 budget will include the EM mission funding as well as pension funding. Mr. Todd replied that regardless there will always be some of the scope funded and some which is not.

Mr. Howard asked if active duty military is involved with training and land use on SRS. Mr. Todd responded that they have not had any success but the site could potentially support a battalion including facilities. He further noted SRS has versatile capabilities for such an endeavor. Mr. Howard suggested offering an SRS tour to visiting military commanders who are in town to visit Fort Gordon.

Mr. Kaminski asked for a motion to move this response to the full board for closure, which was granted, seconded, and voted to pass with a full majority.

Committee Discussion: SR Archaeology

**Mr. Allensworth asked how SRARP works with the Curation Facility. Ms. Hammett answered that the curation facility is split between the Cold War preservation program and the archaeology program.**
