Site ALARA Committee and Change Control Board Meeting 2nd Quarter 2022 Review

The Site ALARA Committee and Change Control Board meeting was held via Microsoft Teams.

Rollcall was performed. Dennis Carr was not available when roll call was originally made, so JC Wallace offered to Chair the meeting in his absence. Kent agreed and Dennis later joined the call. Quorum requirements were met for the SAC and CCB. (See attached)

1. Introduction: Kent Williams/Pamela Powell

Kent welcomed everyone to the meeting then turned it over to Pamela Powell for the safety topic. Pamela discussed the safety topic which was vehicle safety. A safety flash was received on August 17, 2022 from SRMC that stated an employee was delivering water to hand washing stations in H-Tank Farm and exited the government vehicle with the engine on and in gear. The vehicle rolled backwards about 30 feet and struck a storage container. Manual 8Q procedure 11 states that before leaving the driver's seat, the driver shall: put automatic transmission in park, set the brakes and stop the engine. This occurrence is a reminder to be aware of procedure requirements for operations of motor vehicles. Kent commented that many newer vehicles are equipped with the rotary gear shift so individuals with this in their personal vehicles should be aware of this possible hazard. Kent added to the safety topic and talked about deer impacts and speeding policy. Kent then discussed the ACL extensions given to the individuals in K-Area. He turned the meeting over to Teresa Eddy for the Environmental ALARA overview.

2. Environmental ALARA: Teresa Eddy/Eric Doman

Teresa Eddy introduced Eric Doman as the Environmental ALARA Chair. Eric discussed the Environmental ALARA Guides status for Liquid Discharges and Airborne Emissions. (See attached.) No changes are requested at this time.

Kent asked if the projected 10.9% of the liquid discharges ALARA guide for the year was sufficient. Eric responded that the facilities are conservative with the percentages to expect some variation so 10.9% should be sufficient. Next Kent asked about the higher projected percentage of guide in H-Area Liquid Discharges which was 113.6%. Eric explained that based on the March report, Environmental ALARA requested an increase for H-Area liquid discharges from 5.02E-4 to 5.02E-3, which was approved. This approval decreased the projected percent from 134% to the 113.6% and should continue to decrease.

3. Review of YTD Quarter Performance: Diana Jennings

Performance Indicators were reviewed. (See attached)

Diana Jennings commented that BSRA data was not included within the information pulled from Scorecard, and they did have a radiological event that resulted in an uptake so Kevin Webster was given the floor to discuss. Kevin stated that BSRA had a Non-ORPS occurrence when a CAM alarm in room C-075, Building 773-A was received. This resulted a positive chest count and a positive bioassay sample for the individual in the room. It was determined that an uptake of less than 500 mrem but greater than 100 mrem had occurred. Since this was not included in the information pulled from Scorecard, this process will be revised for future meetings.

CLB- Terry Pifer stated focus was primarily on 235-F work however they do expect to do more decommissioning jobs during the 3rd and 4th Quarter. They do not request any changes at this time.

BSRA- Kevin Webster stated that BSRA is 3 months behind on shielded cell work which is reason the dose total was low. They expect to do the work in the 3rd and 4th quarter so the dose is expected to rise. No changes are requested at this time.

Ouestions or Comments

JC Wallace commented on the ALARA process and how the facilities were planning the ALARA Goals well. He commented on how the actual dose totals seem to be consistently lower than the goal. With that observation, he also asked were the ALARA goals being set to be challenging. Dennis Carr responded stating all facilities base their ALARA Goals on previous quarters and data, and adjustments are made as needed.

Dennis then asked about how the dosimetry contractor Landauer was performing. Kent answered that they are responding well. They are doing monthly readings for K-Area to help avoid personnel exceeding the ACL. He also stated that external dosimetry is preparing to visit Landauer and observe their processes this month. Dennis suggested that during the next ALARA Committee meeting, external dosimetry do a presentation on how Landauer is performing.

There were no other comments or concerns. The meeting was adjourned.


