Proposed Action Title: Removal and Disposal of Lead Shielding in Cell Rack

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Currently there is a stainless-steel shielding rack located in cell 10. Lead shielding is encased in stainless steel. Workers will need to remove bolts to separate the lead from the rest of the rack prior to disposal of both the rack and the lead. Lead and rack will be disposed in different waste streams per ECA/GCO direction. Technical work documentation is Work Order 1991935.
