Proposed Action or Project Description:

Room 169 is being modified to accommodate office spaces throughout the room, resulting in deficient notification device coverage as required by NFPA 72, 2016. Existing notification appliance will be relocated and an additional new notification appliance will be installed to provide adequate coverage as required per NFPA 72 requirements.
