Proposed Action Title: Venting of Expired DOT Permitted Cylinders

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

There are 31 cylinders in 731-6N that bear expired DOT permit marks (denoted by DOT-SP or DOT-E) that have been disallowed for shipment back to NexAir for reuse. We plan to vent them to zero pressure and then move them to our salvage cylinders population (being held for another project and contract to destroy them as scrap metal). Our goal is to prove no pressure (therefore no longer hazardous and no concern in their subsequent movement) but if pressurized, to vent them.
