Project Title: Platform Repair at Radiological Stream Surveillance Location FM-A7

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken/South Carolina

Proposed Action or Project Description:

Stream surveillance location FM-A7 is part of the routine monthly stream surveillance sampling program on Four Mile creek. This location has 2 separate platforms, one which allows technicians to enter the stream bed as needed, and the other actually holds the ISCO composite sampler and other sampling equipment. The base of the platform which allows technicians to enter the creek has eroded due to high flow volumes causing the platform to be unlevel and unsafe. Maintenance will have to dig/grade with hand earthen tools around the creek in an SCA to correct the platform. The ISCO sampling platform has a slippery surface and is therefore unsafe. Maintenance will install non-slip fiber grading. See picture attached of platform in woods, which is used by technicians to enter the creek.
