Proposed Action Title: Saltstone Disposal Unit 6 Leak Detection Sump

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Saltstone Disposal Unit (SDU) 6 leak detection system is almost always in alarm due to ground / rainwater intrusion into the High Density Polyethylene (HDPE) liner around the perimeter of the SDU 6 foundation. Temporary modification SSF-TMC-18-003, "SDU 6 East Leakage Detection Sump Dewatering Modification," has been installed to aid in the response. The Temporary Modification has proven to be effective, therefore, it is to be converted into a permanent design per Manual E7. Revision 2 incorporates an additional Temporary Modification to add piping to direct the SDU 6 East Sump contents back into SDU 6. Once in SDU 6 the liquid is combined with the drain and process water in SDU 6, which is transferred to the Saltstone Production Facility for treatment and subsequent disposal by installed pumps.
