Proposed Action Title: Installation of SoilVUE10 TDR Soil Moisture and Temperature Sensor

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This project will install a soil moisture and temperature sensor (SoilVUE10 from Campbell Scientific) near our meteorological tower (building # 623-49G). The project will require digging a narrow hole to a depth of 1 meter. The instrument will be installed in the hole and remain there for, at a minimum, the duration of the funded project, planned to last through September 2025.
