Proposed Action Description:

The goal of the Catalyst R&D is to create innovative materials and intellectual property. This project seeks to develop a high-performance catalyst with significantly improved activity. Improved catalysts will be prepared by several different techniques including (1) impregnation, (2) vapor deposition, and (3) ion-exchange. The goal is development of a catalyst with 10x performance, if not 100x, comparing to the current technology on energy and material conversion. This EEC TC-W-2018-0074 is a minor revision of analytical activity covered in EEC TC-W-2012-0089 rev.1

Rev 1: extends the end date of this ongoing R&D activity to 4/30/26. There are no other changes for Revision 1.
