Proposed Action Title: Operation of Automated Sievert Apparatus

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Operation of the automated Sieverts apparatus to measure the gas absorption-desorption behavior of small quantities (micrograms) of hydride material (lanthanum, nickel, palladium, titanium, aluminum, iron as well as alloys of these materials) at low pressures (0 to 1200 Torr) will be performed in 999-2W lab 141. This apparatus is composed of automated valves that are remotely controlled using LabVIEW.

Rev. 1 extends this ongoing activity.
