Proposed Action Title: 749-A, Remove Equipment & Install (2) Doosan CNC Machines for R&D

Proposed Action Description:

Dismantling and removal (D&R) of (2) items of equipment: an Ikeda RM-1375 radial arm drill press, and a Bridgeport Series II Interact-CNC Mill. Then the installation of two (2) new Doosan CNC Mill machines, a DEM 4000 and DNM 4500, that will be locally installed respectively in place of the IKEDA drill press and in place of a HAAS TM2 mill machine (to be relocated).
