Proposed Action Title: 235-F Post Cold & Dark

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC supports activities post Cold & Dark status of Building 235-F. This revision includes the following proposed activities: deactivation of the 235-F Metallurgical Laboratory waste handling equipment and draining of liquids from the 252-20F transformer. The scope includes the mechanical and electrical isolation of the equipment and modification of containment areas to prevent accumulation of rainwater.

Rev. 3 summary: This revision includes mechanical and electrical isolation followed by removal and disposal of ancillary equipment and facilities external to the 235-F FAMS (F-Area Material Storage) building that do not affect facility integrity.

Rev. 4 summary: This revision includes the proposed activity of cutting various conduits to grade and then the grouting of them in Building 720-F and exterior of 235-F.
