Categorical Exclusion Determination Form

Proposed Action Title: Replace Inert Loading Panalarm and Temperature Recorder in Room 324 of Building 234-H

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Replace the existing capability of the alarm / indication panel and temperature chart recorder with an SRNL designed Digital Acquisition System (DAS) that can consolidate the existing functions of the control panel using a LabVIEW program interface. This will require installation of a communication module with cabling from the new control panel hardware to the existing field instrument hardware.

Some of the components of the inert loading control panel, T411-13B-1, have become obsolete. The temperature chart recorder is a paper strip-chart recorder. It is no longer available for replacement. Also, the Panalarm cards housed within the control panel are obsolete and cannot be replaced. They are an integral part of operation of the valves, pumps and compressors in Inert Loading System for Loading Lines 1 and 2. These components have also been identified as being vulnerable to failure, which when combined with their obsolescence, could compromise the facility's ability to continue satisfying its mission requirements.

Revision 0 of this EEC currently addresses the design and procurement portions of this modification. This EEC will be revised to include the facility modification portion of the work prior to construction and installation.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
