Proposed Action or Project Description:

The 115 kV transformers, both switchgears A and B, associated 4160V secondary cables, protective relaying, breakers, and control wiring, 480V transformers and control wiring should be replaced with new. The new switchgear will consist of two busses. Each 4.16 kV bus will house 7 breakers including a bus tie breaker, for maintenance purposes, and a spare. The bus ties will be normally open and electrically interlocked with the transformer secondary breakers to prevent paralleling the transformers. Power and control wiring will be replaced based on new switchgear arrangement. New switchgear installation will include motor protection; feeder, transformer and bus protection relays; alarm circuits, and SCADA connections. Options will be to install spacer bus sections so new 4160V equipment aligns with old or reconfigure to accommodate newer compact footprint.
