Proposed Action or Project Description:

SRNL Research and Development Engineering will be conducting a fire suppression test in 723-A to support the Surplus Pu Disposition Project in K-Area. This test involves releasing NOVEC pressurized with Nitrogen into a controlled volume and observing the pressure and temperature changes within the control volume. The NOVEC and Nitrogen released into the control volume will be released to the environment upon completion of the test.

- There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal would not threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of Appendix B to Subpart D of 10 CFR Part 1021; involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements.
