Proposed Action or Project Description:

The South Carolina Department of Transportation (SCDOT) will replace the existing bridge on State Road 66 (Rocky Point Road) over Lower Three Runs Creek in Allendale County. SCDOT will obtain an easement from DOE-SR for the bridge replacement. Sediment/water sampling and geotechnical surveys will be required to determine bridge design.
