Proposed Action or Project Description:

Proposed activity provides for the procurement and installation of a backup set of Dead Weight Testers in the Building 234-H (HAOM) Hot Calibration Laboratory. An increase in Tritium production requires increased testing from the Hot Cal Lab in HAOM. A backup set of Dead Weight Testers is needed to meet throughput increases and to ensure down time is minimized.
