Proposed Action or Project Description:

The purpose of this EEC is to support the administrative action of processing a successor Land Use License for The Ellenton Heritage Trail, located on 5.89 (+/-) acres of DOE-owned property on the Savannah River Site (SRS) (see attached Exhibits A-1 & A-2). This will replace the original license that expired in 2019 and allow the SRS Heritage Foundation to resume escorted public tours of the former town of Ellenton, SC.
