Proposed Action Title: Isolation and Removal of Equipment from Building 226-2F to Building 711-N for storage until needed in the 717-F machine shop or for reuse in 711-N

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Isolation and removal of several pieces of equipment originally used by MOX from Building 226-2F to Building 717-F, to Building 711-1N or to available connexes in the SRPPF area for storage until the equipment is needed in the 717-F machine shop. Preparation includes, but is not limited to, air gapping electrical and air lines that are connected to the equipment, removal of any residual coolant, and removal/relocation of equipment.
