Proposed Action Title: Install Replacement Refrigerant Conversion Kit to Air Handling Unit at 226-2F

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Due to a catastrophic leak on October 13, 2022, the Air Handling Unit (AHU) F-226002-HVAC-AHU-RTU1 discharged all R-22 refrigerant. This EEC will cover activities related to adding a conversion kit to the AHU to enable to unit to use R-22 replacement refrigerant, R422B, or equivalent. It will also cover the same activities for F-226002-HVAC-HVAC-RTU2, if necessary.
