Proposed Action Title: Diffuser R&D in 999-2W Lab 156

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Alternative Pd/Ag diffuser designs are being explored with the goal to evaluate the feasibility of continuously recycling mix tanks through a diffuser to remove He-3. A manifold will be used to investigate various process conditions, including, flow rate, pressure, shell pressure, etc., using assorted mixtures of H₂, D₂, and He-3. The manifold will be altered as needed to facilitate testing and will include the use of a Thermcraft XST split tube furnace to heat the diffuser 'shell' and contained Pd/Ag tubing.
