Proposed Action Title: Excavation Near General Purpose Evaporator (GPE) to Support HP-50 Low pH Investigation

Proposed Action Description:

The scope of the activity includes the chipping and removal of material approximately 1.5' x 4' to expose the area in front of the recycle sump located west of the GPE. This excavation is to support HP-50 low pH investigation.

Revision 1 includes the sidewalk repair of the excavation once riser repairs have been completed.
