Proposed Action Title: PAR Pond Dam Emergency Spillway Redevelopment

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The purpose of this project is to return the emergency spillway at PAR Pond to as close to its original design configuration as feasible. The area has been surveyed for radiological contamination and none was identified. Radiological monitoring will be performed while work is in progress. If radiological work is later determined to be required, a separate Statement of Work will be generated. In general, tasks for this project include: Tree and stump removal, verifying channel grade, construction of a rip-rap berm, construction of a diversion berm, seeding and grassing the completed channel, and erosion control until a permanent vegetative cover is established.
