Categorical Exclusion Determination Form

Proposed Action Title: Install Two Additional DeltaV Workstations in the Building 233-H Central Control Room

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Per modification traveler MT-TRI-2024-00002, two additional unclassified DCS workstations are required to be installed in the Building 233-H Central Control Room (CCR) prior to the replacement of the General Services programmable logic controller (PLC) under YCON-14. The PLC controls and monitors the 233-H HVAC system, the 249-H cooling tower system and the 249-H HVAC chilled water and process chilled water pumps.

Under YCON-14, the GS PLC will be replaced by DeltaV Characterization Modules (CHARMs) I/O and a PK Controller. In order to support the project plan to install the GS DeltaV CHARMs I/O and PK Controller, it is necessary to first install a DeltaV DCS communication link. There currently is DeltaV front-end equipment installed in the Building 233-H CCR that could be used to enable the communication link. In order to use this link, Operations requires that two additional DeltaV operator workstations be installed in the CCR.

A draft of the modification traveler is available in SPF.

Revision 0 of this EEC currently addresses the design and procurement portions of this modification. This EEC will be revised to include the facility modification portion of the work prior to construction and installation.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
