Proposed Action Description:

Testing of heater capability in support of He-3 recovery from retired hydride beds will be conducted at 999-2W. "Clean" beds and lanthanum nickel aluminum hydride (LANA) that have not been exposed to tritium will be used as surrogates for process beds.
