Proposed Action Description:

CM 4493 Install light under awning weld test at 711-2N. Install supports for new LED fixtures and conduit under awning in 711-2N. Install new LED fixtures under awning. Install switch to control new fixtures. Finish conduit run inside 711-2N and tie into CKT 23, fed from Panel D. Replace existing obsolete fluorescent fixtures with LED equivalent fixtures.
