Proposed Action Title: 730-4B Culvert Repair

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Replace a failing 42-inch corrugated metal pipe (CMP) located at the southeastern side of 730-4B building with a 42-inch class III reinforced concrete pipe (RCP) culvert. The pipe culvert starts at catch basin number 16 (CB #16) and extends approximately 90 feet to Head Wall number 4
