Rev. 0: A more suitable location to gauge field parameters at station L3R1-A was identified. The following activities will take place to establish the new location for sampling: Site Infrastructure will install two posts across stream at the L3R1-A gaging station. The area will be mowed for access. Site Rigging will install a pulley system across stream.

Rev 1: Install new wire/tighten up pulley system for RiverSurveyor.
