Proposed Action Title: Applying Grass Carp and/or ProcellaCOR SC to Reduce Hydrilla in Phytoremediation (MWMF) Pond

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The operation of the Phytoremediation system at the Mixed Waste Management Facility has been affected by the overgrowth of hydrilla in the pond. Multiple options have been considered amongst USDA Forest Service, DOE, SRNS, SREL. In conclusion, the decision was made to add grass carp and/or ProcellaCOR SC to reduce the hydrilla in the pond to prevent the hydrilla from interfering with the operation.
