Three (3) groundwater monitoring wells (i.e., RGW-16-C, CSB-020-B, and CSB-020-C) will be abandoned in place and three (3) replacement monitoring wells (i.e., RGW-16-CR, CSB-020-BR, and CSB-020-CR) will be installed in C-Area.
