Proposed Action Title: Saltstone Facility Like-for-Like Dust Collector Replacements

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The Saltstone Facility dry material dust collectors are to be replaced over the next few years due to being outdated and obtaining parts for corrective maintenance can be difficult. Most will be a like-for-like replacement. One dust collector has been replaced to date (Z-205000-BMH-DCOL-0001), which required a SCDES Construction Air Permit. One dust collector (Z-205000-BMH-DCOL-0002) for Silo #4 is awaiting replacement and a separate EEC (LWO-Z-2024-00001) has been completed. This EEC will cover the balance of the dust collector replacements and will be revised as design details for each dust collector replacement becomes available.
