Proposed Action Title: Shielded Cells Pu Glass Fabrication and Testing

Proposed Action Description:

Testing will be performed in the 773-A E-wing Shielded Cells. The glass will be composed of frit, non-radioactive simulant (fabricated at 999-1W), Fast Critical Assembly (FCA) simulant made at SRNL containing Pu from SRS HB line, and additional raw materials to add U, Th, and Gd.
