The proposed activity (PA) is a redesign of the existing Modular Stripper (MDST) blowers under MT-TRI-2021-00034. It redesigns the existing MDST blowers to a more compact, reliable, and an easier to work on design to reduce the amount of down-time caused by blower failures.
